Once the application process is complete, Seawide will provide notification by e-mail. Nothing contained in this process guarantees that you or the applicant company will be approved as a Dealer.

**PAYMENT TERMS:** Advanced payment by bank transfer is mandatory on all international orders (requests for open terms are subject to credit approval – see full Terms and Conditions at: [www.seawide.com](http://www.seawide.com)). Bank transfer information will be supplied to customer upon first order.

**SALES TAX:** For product shipped, delivered, or will called into the states of California, Florida, or Washington, to an address other than a freight forwarder for export, Seawide must receive appropriate resale documentation before or with order to avoid sales tax. Note: Certain providences of Mexico require Mexican Merchant Cards for California shipments, deliveries, and/or will calls.
