

Dealer Information

Thank you for your interest in opening an account with Seawide Marine Distribution. Please complete, and sign our two-page Dealer Application along with the applicable resale card/certificate (see Sales Tax section below). Completed applications can be submitted to our accounting department via mail, fax, or e-mail. Mailed applications should be sent to our Murrieta address as shown above. Faxed applications can be sent to 951-600-8530 or 949-645-7204. E-mailed applications can be sent to accounting@seawide.com.

We will process your application as quickly as possible. Much of the timeframe will depend on the completeness and accuracy of the information on the application and also on the promptness of trade reference responses, when terms are sought.

If you need to have an order filled before terms are set, we can ship your orders COD (\$2,500 to \$5,000 depending on company longevity), COD Certified, prepayment, or with credit card payment at the time of shipping. Please notify the sales person of your preference. A “Credit Card Authorization Form” must be completed when paying by credit card (see page 3).

Once the application process is complete, you will be notified of the outcome by fax or email.

SALES TAX: If your business is located in the states of California, Florida, or Washington, or you do business in the states of California, Florida, or Washington and your purchases are for resale, we require a completed, signed Resale Card/Certificate or Watercraft Exemption (see pages 4, 5, 6, for CA and WA— only complete the one that is applicable—for FL, send a signed copy of your current resale certificate). *PLEASE NOTE THAT WE MUST CHARGE SALES TAX ON ALL ORDERS SHIPPED TO, DELIVERED TO, OR WILL CALLED IN THE STATES OF CALIFORNIA, FLORIDA, OR WASHINGTON UNTIL WE HAVE A RESALE CARD (OR SIGNED CERTIFICATE COPY FOR FLORIDA) ON FILE.* A copy of your resale license may accompany your completed re-sale card/certificate for CA and/or WA, but it may not take the place of the resale card/certificate form.

PAYMENT OPTIONS: Open account (subject to credit approval), C.O.D., Bank Transfer, M/C, VISA. Advanced payment by bank transfer is required on all international orders. A “Credit Card Authorization Form” must be completed when paying by credit card (see page 3).

FINANCE CHARGE: Accounts not paid within terms are subject to a 1.5% monthly finance charge.

RETURNED CHECKS: All returned checks will be subject to a \$25.00 processing fee and may result in a change in account payment terms.

WARRANTY: All units are covered by a factory warranty. Many products have a 30-day out-of-box failure exchange policy. For products covered by an out-of-box failure policy we can assist with obtaining service or exchanges for these items. Units beyond the 30 day out-of-box failure period that require service either warranty or otherwise, should be returned directly to the appropriate manufacturer.

RETURN POLICY: Seawide provides a 30-day return policy for stock items. Special order items may not be returned for credit.

Seawide reserves the right to return freight collect items returned for credit or replacement that are not in new condition and packed in the original factory carton.

All other returns are handled on a case-by-case basis and are subject to a 15% restock fee.

Note: RMA's expire 30 days from the date issued. Please insure all returns arrive in our warehouse within 30 days of receiving the RMA.

SHIPPING AND HANDLING: All shipments include charges for freight, handling and insurance based upon carrier rates. Seawide Marine uses UPS, USPS, FedEx, and assorted trucking companies. Seawide ships all items F.O.B. destination, and is not responsible for any items lost or damaged during transit. Please refuse to accept any items that arrive damaged. **It is the customer's responsibility to file a claim with the appropriate carrier for any damaged items that are received.**

WATERCRAFT EXEMPTION CERTIFICATE

I HEREBY CERTIFY: That the watercraft identified below is used

- () In the transportation by water of persons or property for hire in interstate or foreign commerce*;
- () In commercial deep sea fishing operations and the watercraft is used outside the territorial waters of this state;
- () In transporting for hire persons or property to vessels or offshore drilling platforms located outside the territorial waters of this state;

That all tangible personal property which I shall purchase from
SEAWIDE MARINE DISTRIBUTION

described on purchase orders, or invoices, as tax exempt under Section 6368 of the Sales and Use Tax Law and Regulation 1594 consists of watercraft or tangible personal property becoming a component part of watercraft in the course of constructing, repairing, cleaning, altering, or improving the same, which watercraft will be used principally in the operation checked above.

**Note: Revenue and Taxation Code section 6368 (b) creates a rebuttable presumption that you are not regularly engaged in commercial deep-sea fishing if your gross receipts from such operations are less than twenty thousand dollars (\$20,000) a year. Revenue and Taxation Code section 6368 (c) creates a rebuttable presumption that the watercraft is not regularly used in interstate or foreign commerce if your yearly gross receipts from such operations do not exceed 10 percent of the cost of the watercraft or twenty-five thousand dollars (\$25,000), whichever is less.*
